DESCRIPTION OF SERVICES TO BE PROVIDED:***CONNECTION TO OUR CENTRAL MONITORING STATION (Central Receptora de Alarmas (CRA))***

The CRA will receive and verify all alarm signals. This service includes, in addition to signal verification, the contact of persons listed by the client as well as Law enforcement agencies and emergency services when required, following with the established operational guidelines and the Law on Private Security.

IMMEDIATE RESPONSE TEAM (Servicio de intervención inmediata (SII))

It constitutes an immediate response to alarm signals by professional security guards; which are fully trained for high risk situations, and that will physically inspect the premises, issue full situation reports, and be in constant contact with the CRA, Law enforcement agencies, and emergency services.

It is an option to the standard service package and can be requested on different conditions and levels; which will be completely described at the moment of hiring.

KEY SAFEKEEPING

The client has the option to entrust Prosegur with a copy of the premises access keys; which are going to be coded and stored at all times inside a safe in the office bunker. They would only be accessible to authorized personnel from the client and to the immediate response team in accordance with the current legislation.

For an additional fee this can be hired independently from the standard service package. Nevertheless, it is a requirement if the SII service is hired, in which case no extra fees shall be applied.

CUSTOMER SERVICE

All clients benefit from a 24/7 telephone line for inquiries, modifications, claims, and suggestions; with English speaking personnel, in Spain at 902.202.999 and from abroad at +34.911.753.501.

ELECTRIC SHORTAGE WARNING

The CRA will contact the persons listed by the client, according to the established operational guidelines, when an electric shortage is detected on the premises and after a 4 hour standard period has gone by.

Such warning, unless modified on the contract conditions, will be done by telephone during daily hours (from 08:30 to 22:30).

Each client can hire, for an additional fee, an immediate notice as well as contact through SMS.

PROSEGUR WEBSITE

This service allows the client to access its own private area for verification of personal information, system status, and services hired. Through the "Acceso Web" our clients can keep informed at all times and also keep their records updated without losing precious time.

In order to be able to benefit from it a user name and password must be set previously, by calling our customer service line.

ANNUAL RISK REASSESSMENT

Our professional staff will visit the premises once per year in order to ensure all risks are kept to a minimum, to present new technologies, and to prepare a detailed report on safety management; including any modifications requested by the client.

CANCELLATION NOTIFICATION

This service provides the assurance to the client, if a mistake occurred during the disarming of the system, that our CRA is fully aware of the situation, that it will immediately respond to it, and that it will act according to our operational guidelines if an unusual event is discovered.

PASSWORDS

Additional to any user codes issued at the time of installation or afterwards every client will receive 2 passwords; the first, for identification purposes when the client contacts Prosegur or is contacted by Prosegur, the second, so that the client can verify if the caller is in actuality from Prosegur.

COMMUNICATIONS

All Systems monitored and installed by Prosegur will be proven on a constant basis to provide extra security measures and allow our technical department to react immediately if a fault is detected in the communication outlet.

PREVENTIVE MAINTENANCE

Following with the operational guidelines and the private security Law, all systems monitored and installed by Prosegur will be inspected thoroughly on an annual basis; even if there are no faults, so that the correct functioning is ensured.

If it is the clients request this visit can be scheduled more than once per year for an additional fee, by specifying it on the service contract.

MOBILE NETWORK

All systems in Prosegur's portfolio have the possibility to use a Mobile network for communication purposes, additional or instead, of a standard telephone line. Depending on the system installed this can be through a GSM module or a GPRS module; which will be determined before hand.

As part of this service Prosegur will issue a corporate SIM card and all costs related to the service will be hired as a single package.

EQUIPMENT WARRANTY

All equipment installed by Prosegur has a limited warranty and is directly related to the purchase or renting. A full description of it will be given at the moment of hiring the services.

ALARM VIDEO VERIFICATION

The provided system has a capability of recording 10 seconds of video in complete darkness if it is triggered; and which will immediately be sent to the CRA in order to view and to study the event, with a possibility of requesting additional footage or gain access to all remaining cameras.

This will allow the CRA to assess the situation in a faster and more accurate way, thus provide an extra security benefit for the client.

IMAGE CUSTODY

All footage recorded will be available to the client upon request for legal purposes and for personal reasons, if correctly justified.

The maximum period of image storage is of 30 days.

PROMOBILE

Is an application developed by Prosegur, with the highest security protocols that allows in its main remote features a total and/or partial connection of the alarm, disconnection, status check, activity requests, and image requests, also available in many different languages and compatible with all Andriod devices, plus others. [The Promobile package allows the remote connection of the system 30 times per month and the request of up to 10 images per month; the Promobile+ package allows the remote connection of the system 90 times per month and the request of up to 30 images per month.](#)

VIDEO SURVEILLANCE

Before an alarm jump, Prosegur will have remote access to the video recorder and check the images in real time. In this way we can give notice to the security forces of what is happening in housing/ trade. You must have ADSL.
